

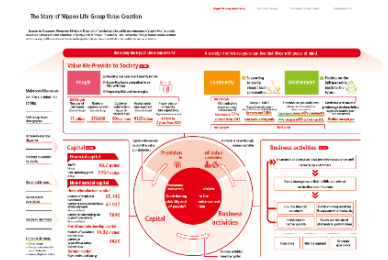
**The Publication of the "Nippon Life Integrated Report 2024" in English**

- Value We Provide <People • Community • Environment> (Main Part P.18-23)

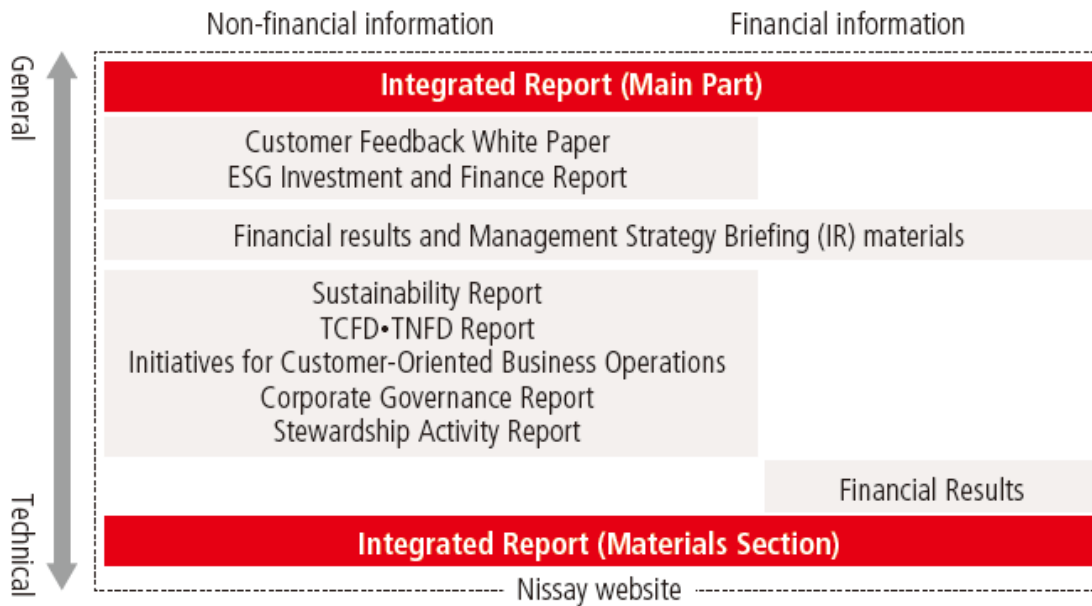
